1 Defendant, Maricopa County Community College District, submits this Notice of
2 Supplemental Authority supporting its pending Motion for Judgment on the Pleadings.

3 MCCCCD supplements its briefing on page 5, footnote 2 of its Motion for
4 Judgment on the Pleadings with citations to A.R.S. §§ 1-502(G) and 23-212(D), which
5 provide examples of immigration-related statutes that include enforcement mechanisms,
6 but provide no authority for the Attorney General to institute actions to enforce them.

7 A.R.S. § 1-502(G) provides that residents of this state have standing to bring suit
8 against a political subdivision for violations of the verification process through which an
9 individual's eligibility for federal or state and local public benefits is determined.

10 A.R.S. § 23-212(D) provides that the county attorney shall bring actions against
11 employers for knowingly employing unauthorized aliens.
