# **BIOGRAPHIES**



#### **JUSTICE FRANCES BOURLIOT**

Frances Bourliot was elected to the Fourteenth Court of Appeals in 2018. Justice Bourliot began her legal career as a staff attorney with the Texas Defender Service and the Texas Innocence Network, representing indigent capital clients on federal and state habeas appeals. She was also an Adjunct Faculty Member at the University of Houston Law Center for several years overseeing the Death Penalty Clinic and co-teaching Innocence Investigations. She then joined the Appellate Division of the Harris County Public Defender's Office when it opened in 2011 and continued to work as an Assistant Public Defender in the appellate, mental health, and felony trial divisions until 2017 when she started her own practice. She joined a plaintiff's law firm in 2018 and represented clients in personal injury, medical malpractice, and appellate matters.

Justice Bourliot has taught CLEs on *Batson* challenges, jury charge issues, mitigation, and mental health related topics.

Justice Bourliot received her J.D. from the University of Houston Law Center and a Bachelor of Arts from Tufts University.



#### **GEOFFREY A. HOFFMAN**

Professor Hoffman is the director of the Immigration Clinic at the University of Houston Law Center and a clinical professor. He specializes in immigration-related federal court litigation, deportation defense, asylum cases, and appeals before the Board of Immigration Appeals. He has represented numerous immigrants in a variety of settings including before the Executive Office for Immigration Review, Department of Homeland Security, and in the federal courts. Professor Hoffman served as co-counsel before the Supreme Court of the United States in the precedent-setting immigration case, *Carachuri-Rosendo v. Holder*.

Professor Hoffman is a frequent commentator on immigration law and policy. He has been quoted in the New York Times, Wall Street Journal, Time, Mother Jones, Reuters, Bloomberg News, Houston Chronicle, among other outlets. He has published articles in the following representative law reviews: Maryland Journal of International Law, Journal of Gender, Race, and Justice at the University of Iowa, Houston J. of Int'l Law-Sidebar, Houston Law Review-Online, Nova Law Review, Loyola L.A. Int'l and Comparative L.J. He also has published pieces in Salon.com, Jurist, Immigration Professor's Blog, Lexis Nexis Immigration Legal News, and Notice and Comment, a blog from the Yale Journal on Regulation, among other venues.



# **SHARAD S. KHANDELWAL**

Sharad S. Khandelwal is a federal prosecutor at the U.S. Attorney's Office for the Southern District of Texas. He is currently the Deputy Criminal Chief of the Human Rights and Organized Crime Section, where he oversees a dozen prosecutors and the civil rights, child exploitation and sex trafficking, immigration fraud, and organized crime caseloads. Assistant U.S. Attorney Khandelwal graduated from the University of Texas at Austin in 1995, and the University of Michigan Law School in 1998, and clerked for the Hon. Carl E. Stewart, who serves on the U.S. Court of Appeals for the Fifth Circuit. He has served as a federal prosecutor for over fifteen years, and received the 2015 Prosecutor of the Year Award from the DEA, Houston Division. Three years ago, he led the trial team in *United States v. Marg Perez*,

No. 17-35, which prosecuted the 2017 hate crime arson of the mosque in Victoria, Texas. He received the Attorney General's Award for this successful prosecution, which resulted in an almost 25-year sentence.
