Course Description:

This course will address recent legal and ethical issues concerning brain development and defects, brain functioning, and brain imaging. Topics will include:

- Mild, moderate and severe brain injury
- Disorders of consciousness, such as vegetative states and minimal consciousness
- Recent controversies concerning sports injuries, such as concussions, chronic traumatic encephalopathy (CTE), etc.
- Brain injury or defect and behavior related to criminal responsibility
- Brain treatments such as psychosurgery or deep brain stimulation, and brain research
- Brain loss such as Alzheimer's Disease and other dementias
- Brain death policies

Texts:

 All readings will be provided by the instructor. Supplemental readings will be recommended.

Requirements:

Seminar paper of at least 25 pages exclusive of footnotes is required. There will also be a required oral presentation of the seminar paper in class. Details of the presentation will be discussed in class. The papers may be based on legal cases, statutes or regulations. You may also assess current or proposed brain policies and practices in treatment or research. Interdisciplinary research on specific issues connecting law, ethics and brain policies is also acceptable.
