Objectives:

- 1. Students will learn the constitutional principles that guide state juvenile justice systems.
- 2. Students will consider practical and ethical issues that arise in the practice of juvenile law.
- Students will be able to integrate their knowledge of juvenile law, nationally, into the practice of law and development of juvenile justice policies.

- **30 Points** A short paper, no more than six (6) pages, which will be based on your court and/or facility observations. More information about this assignment will be distributed early in the semester. This assignment will make up for two cancelled classes in September.
- 200 Points A final exam that will include one policy based question (distributed during the semester and due the last class session) and one practice based question to be given at the scheduled exam time.
