All students are to have read the entire assignment in preparation for each class meeting. I will call on students at random, although I will typically announce a three-student panel at the beginning of each class. If you are unprepared when I call on you, you will be marked absent for

the day. The second time you are unprepared, your final grade for the course will be lowered by 1/3 (*e.g.*, a B becomes a B-). Any student who is unprepared more than two days will be dropped from the course.

Both the midterm exam and the final exam will be closed-book and will *likely* be comprised of a combination of essay and multiple-choice questions. The midterm will be worth 25% of your final course grade and the final will be worth 75% of your final course grade.
