SYLLABUS

Required Text:

Henderson, Pearson & Kysar, The Torts Process (9th ed. 2017)

Expectations:

Students are expected to be carefully read the assigned materials, brief all cases, and participate in classroom discussions. Voluntary class participation is encouraged. However, I want to make sure that everyone has the opportunity to participate in class discussions and will therefore call on students who have not raised their hands. You may "pass" if you are unprepared, but passing in excess of once per semester is an indication of poor class preparation and may result in a lowering of your grade.

Attendance:

Regular attendance is required by the ABA, and I recommend that you miss no classes. In the event of a lengthy illness or a single problem causing you to miss multiple classes, please come see me. Missing class in excess of four occasions per semester will affect your final grade.

Grading:

Grades in this course will be based primarily on your performance on the final exam and may be adjusted upward based on class participation or lowered based on frequent absences, inadequate preparation for class, or excessive "passing."

Exam:

There will be a final exam at the end of the course. The exam will be a four-hour closed book essay exam. You will not be allowed to bring any outside materials (textbooks, notes, outlines, etc.) into the exam room – with the exception of one 8 ½ X 11 inch piece of paper with notes on both sides. You will be expected to be able to recite "the law" on the exam, but a significant part of your grade will be based upon your legal analysis: applying the law to the facts, arguing your points and supporting them in a logical, persuasive and organized fashion, anticipating arguments on the other side, and distinguishing predictable outcomes from less obvious issues requiring more analysis. Briefing cases and participating in class discussions will enable you to practice these skills.
