It should be no longer than a single page (and will likely be much shorter), with space between the bullet points, and using 12-point font. ◦ <i>Please DO NOT put your spring exam number in anything that you send me.</i> ◦ I reserve the right not to review any Outline turned in late without my prior permission. ◦ Submitting your Outline for feedback is optional, but it is <i>strongly</i> recommended. ◦ I will give my comments on your Outline during your conference with me during the week of March 19.
