Course: 5218 Human Trafficking Law–Spring 2020 TH 4:00–5:45

**Instructor:** Edward F. Gallagher

**CONTENT:** This class will focus on human trafficking and related state, federal, and international responses to what is now commonly referred to as modern day slavery. We will cover legal and public awareness measures being taken to prevent, deter, and respond to human trafficking, including the social service organizations that are critical to the restoring victims and preparing witnesses in trafficking cases. The class will begin by focusing on the legal definitions and framework of trafficking and move to an historical overview of state and federal laws passed to address trafficking offenses, involving both U.S. citizens and immigrants placed into labor servitude or the commercial sex trade. The Trafficking Victim's Protection Act and its reauthorizations will be covered along with the visas and witness issues that are common with trafficking victims. We will closely cover the federal statutes and the case law that interprets those statutes, including pre-TVPA slavery, involuntary servitude, Mann Act, forced labor, international sex trafficking, sex tourism, domestic minor sex trafficking, private civil actions, restitution, and forfeiture. During the class you will see how this framework guides the United States' effort to combat human trafficking in both domestic and international forms. There will be guest speakers periodically invited to class to make presentations on actual cases prosecuted in Houston, domestic cults, victim services, and public awareness/advocacy campaigns.

GRADE: The grade in this case will be based on a research paper of the student's own choosing that critically examines a human trafficking topic related to class. The paper topic must be approved by the professor in advance. The paper must be no less than 15 and no more than 20 pages, double-spaced, 14 point font. I will provide additional guidance on the format and content during the class. Attendance and participation will comprise 10% of your grade. The paper will comprise the remaining 90% of your grade.

**ATTENDANCE**: The law school mandates that you attend 80% of the classes. You must comply with this requirement. Attendance will be taken each class.

<u>PARTICIPATION</u>: The class will be more beneficial to all if you participate in discussions and make a good faith effort to read all of the materials. This will also improve your grade.
