Course Assignments

Class Discussion and Participation

You will be graded on how much you participate in the class discussion. A max of 70 points will be earned for participation points. (5X14 classes = 70 points).

Lead Class Discussion

From week 4 until week 8, students will be assigned to lead a class discussion. Each student should choose a recent case from either the Court of Criminal Appeals or one of the Court of Appeals. The case should involve some interesting procedural issues. The student will explain to the class why the case is important and walk the class through the facts and holding. Each presentation will take approximately 5 minutes.

Writing Assignment

One writing assignment will be assigned based on a fact pattern provided to you. You will be asked to write one appellate issue (point of error) including argument and authority. Then, you will be asked to make an oral argument on your appellate issue. The paper must be double spaced, 14-point type, Times New Roman, one-inch margins on all sides, and left justified.

Oral Argument Presentation

An oral argument presentation will be done based on your writing assignment. The presentation needs to be at least 10 minutes long and cannot exceed 15 minutes. There will not be a rebuttal argument.
