## C. Case Law

- Researching federal and state cases on environmental law.
  - Search for cases utilizing the West Digest system (either with the print digests or on Westlaw/Westlaw Next) using the topic, "149E Environmental Law."
  - Search for cases with the BNA headnote system, using the subject heading "Environmental Law".
  - Search for cases by headnotes on Lexis using the subject heading "Environmental Law".
  - Environment Reporter-Cases (Bound Volumes), Arlington, VA: Bloomberg BNA, 1970-current. This multi-volume set contains environmental law related court cases. This has a cumulative digest.

# **D. Validating Your Research**

Researching environmental law, as with any area of law, requires the most current and reliable information. As such, it is important to ensure that the primary sources including statutes, regulations, cases, and even administrative decisions that you are relying upon are valid. Use the following tools to validate your research:

- KeyCite (Westlaw/Westlaw Next)
- Shepard's (Lexis/Lexis Advance)
- BCite Analysis (Bloomberg Law)

- Environment Reporter. Washington, DC: Bloomberg BNA, 1970-current. This is a part of a comprehensive multi-volume set that includes the full text of primary sources pertaining to environmental law, but it also includes news that covers topics such as air pollution, climate & energy, waste control & cleanup, water pollution, and state news. There is also a special report section and currently, a section covering the gulf oil spill. The journal section provides an overview of recent environmental legislation, regulations, case law, executive orders, and agency decisions.

# 2. Bloomberg Law

- Contains primary law such as statutes, regulations, and case law at the federal and state level
- Bloomberg BNA Publications listed above are available
- Use Bloomberg BNA Headnotes for Case Law Research
  - o First, click "Litigation & Dockets" from the top of the page
  - o Second, from the drop-down window, click "BNA Headnotes"
  - o Third, click "Environment" from the list of subjects
  - o Finally, choose from the environment cases classification outline, to obtain a list of cases, related to a particular environmental law subject.

# 3. Lexis/Lexis Advance

- On Lexis' search page, click "Area of Law-By Topic" and then click "Environment" from the list of subjects to utilize a page that will list all primary and major secondary sources related to this field.
- On Lexis Advance's main page, click the "browse subjects" link above the search box, click "Environmental Law" from the list of practice areas, and then select from the list of environmental law related topics, and choose "Get topics documents". Select from the tabs at the top or use the search box on the left side of the page to locate materials.

# 4. Westlaw/Westlaw Next

- On Westlaw Next's main page, click the "topics" tab and then select "Environmental Law" from the list. This will display primary and secondary sources related to "Environmental Law."
- On Westlaw (Classic), create an "environmental law" page by clicking the small "add a tab" link at the top right, click the "Add Westlaw Tabs" link, check off the box next to "Environmental Law Practitioner," and then click "Add to my Tab Set" link at the bottom of the page. This will compile a list of primary and secondary sources related to environmental law.
