Course Objectives. In this class, we will focus on developing your legal analysis and communication skills and conducting effective but efficient legal research. This will serve you well as you prepare to write law school exams; create a writing sample to obtain summer employment; and, ultimately, begin legal practice. This semester, expect to master the following course objectives:

- 1. Understand the sources, hierarchy, and precedential value of laws.
- 2. Distinguish different types of legal rules, dissect legal rules into their basic components, and synthesize a unified legal rule from disparate sources.
- 3. Identify legal issues crucial to resolving a client's legal problem; effectively execute online legal research and select appropriate authority to analyze these legal issues.
- 4. Understand and apply case precedent and, when appropriate, enacted law, to resolve the client's case.
- 5. Translate legal research and analysis into objective writing that is organized effectively; conveys all relevant and required substance clearly and concisely; and omits extraneous matters.
- 6. Understand and apply legal citation proficiently using Bluebook and Greenbook citation formats.
- 7. Master grammar and punctuation commonly used in legal documents, and basic tenants of legal style.
- 8. Understand the nexus between substantive law, procedure, legal skills, and ethics.

Textbooks. Please purchase Romantz & Vinson's Legal Analysis: The Fundamental Skill (4th ed.) (ISBN 978-1-5310-2778-0) and McAlpin's Beyond the First Draft: Editing Strategies for Powerful Legal Writing (2d ed.) (ISBN 978-1-5310-2713-1). We will use these books for the full academic year.

In addition, purchase either *The Bluebook*: A Uniform System of Citation (22nd ed.) ISBN 979-8-218-57457-4 OR a subscription to the *Bluebook Online*, available at Homepage | The Bluebook Online (legalbluebook.com). I

don't care which you purchase, the print edition or online; either is fine. You will continue to use this book throughout your law school career. Based on comments from former students, some prefer the print edition *Bluebook* because they like being able to tab, highlight, and annotate it. In contrast, some prefer the online *Bluebook* because it is easier to search.

I will also occasionally provide supplemental materials free of charge on Canvas, our course management system.

Assessment | Late Submissions. The purpose of this course is to teach you to use doctrinal law in a practical setting. Accordingly, I will calculate your grade based on your written work product produced in response to assignments that mimic tasks you will encounter in practice. In addition to your understanding and use of applicable doctrinal law, I will also assess your mastery of citation, grammar, and legal style. Using Generative Artificial Intelligence. As technology develops to address issues of confidentiality, more and more lawyers will turn to generative artificial intelligence ("gen-Al") to improve efficacy and efficiency. Accordingly, you too will need to learn how to use this tool in an effective and efficient manner. We will discuss proper prompting techniques in class and learn to assess Al output critically. This will require that you first learn the basics of critical thinking and how to analyze a legal issue. After you've mastered these skills, I will notify you in writing when and how you may employ gen-Al on specific assignments.
