INTRODUCTION

Course Description:

This seminar is for research and writing. An acceptable topic is one that would typically warrant statutory and case law research in a judge's chambers or law firm. No classroom sessions are anticipated, but some individual meetings and group Zoom sessions will likely be needed for topic selection and progress discussions along the way.

The seminar's writing topics can address issues in the four main areas of intellectual property law:

- A. Patent law. The body of Federal law governing patenting of inventions in the United States and other countries. The subjects of investigation include requirements for obtaining a patent, patent infringement litigation, and patent licensing.
- B. Trademark law. Appellate cases and statutes governing the protectability of marks: trademarks; service marks; collective membership marks; and certification marks. Infringement actions and the remedies available therein.
- C. Copyright law. The Federal statute and decided appellate cases thereunder over the thirty years since enactment of the current statute. Definitions of works of authorship will be investigated, as well as exemptions for fair use, compulsory music licensing, and other special situations.
- D. Trade secret law. State laws will be investigated, along with the Restatement of Unfair Competition and major decisions by state and Federal appellate courts in the area of misappropriation of technical or commercial confidential information.

<u>Prerequisites</u>: Yes. Intellectual Property Survey, or Patent Law, or Patent Remedies & Defenses, or Trademark Law, or Copyright Law, or permission of the instructor

Required Texts: None.

Learning Objectives

The seminar is designed (1) to provide each student with solid professional skill in brief-writing and motion-writing in judicial and administrative cases involving intellectual property law, at a level equivalent to that of third- or fourth-year associate in a law firm; (2) to give each student a realistic opportunity to produce a publishable work in this area, as has often happened in the past; and (3) to provide each student with a high-level legal writing sample for consideration by potential employers.

Assessments: As has been done for several past years in this seminar, the initial outline and the paper will be due in five separate, graded submissions spaced over the semester. The outline will count for 8% of the final grade. Writing Submissions 1, 2, and 3 are the major component parts of the final work. These will be promptly and extensively commented upon by the instructor, using the track-change feature in Word, and will be graded at 20% for each submission. The final composite submission, also commented upon and graded, will count for the remaining 32% of the final grade. It will be due shortly before the last day of classes. In order to keep to the schedule, and in fairness to other students, no time extensions can be allowed.

Learning Outcomes:

<u>Course Grading:</u> The seminar will involve five graded submissions, with scoring apportioned as follows:

January 18 Submission of an outline from preliminary research done on the chosen topic, flagging the statutory provisions to be discussed (8%)

February 16 First writing submissions due (20%)

March 18 Second writing submissions due (20%)

April 4 Third writing submissions due (20%)
