## **Learning Objectives**

The course is designed to highlight in depth the principal substantive law issues, and a few jurisdictional and procedural ones — that are most commonly encountered in patent litigation today, ones that do not arise in Patent Office practice and that are not covered in a basic patent law course. The course will follow my e-book casebook, *Modern Patent Litigation*. We will treat the cases rather thoroughly, and as a result will on average cover only six cases per class session. We will construct and discuss several variant fact patterns of some of the cases.

There will be three not-for-credit quizzes spaced during the semester. Each will be preannounced and will be in multiple-choice format. The final exam in multiple-choice format will count for 100% of the final grade.
