Hello from the Co-Directors of the University of Houston Law Center's Environment, Energy, and Natural Resource (EENR) Center



Welcome to our update on the latest happenings at the EENR Center from the University of Houston Law Center. From the Center's vantage in the nation's Energy Capitol, we often get a preview of the emerging legal issues that will drive the energy and environmental future.

Avulsive changes in federal and state policies on energy and environmental protection necessarily have an outsize impact in Houston and Texas. When the Trump Administration unleashed a record-shattering number of executive orders and revisions to rulemaking procedures in early 2025, for example, it focused on energy and

environmental law as the front line for sweeping change. These first broadsides included, of course, the declaration of national energy emergency that justified fundamental changes to permitting and environmental reviews that swept through Houston's energy sector.

The withdrawal of the United States from the Paris Agreement also arose principally from the current Administration's energy policies – namely, its desire for national energy dominance and promotion of fossil fuels – and its sweeping use of tariffs and deal-making as a substitute for negotiated treaties, international agreements and customary norms.

Beyond executive branch actions, the judiciary has also joined the fray. The U.S. Supreme Court this year ratcheted up the staccato tempo of change by upending its long-standing precedents and norms that had governed statutory interpretation and deference to agency actions for decades. Unsurprisingly, the first cases to use the new legal standards dealt with environmental protection (Loper-Bright v. Raimondo's reversal of the Chevron doctrine) and energy policy (Seven Counties Infrastructure's truncation of NEPA review for natural gas and oil pipeline approvals).

This Mephisto waltz of policy destabilization will almost certainly continue for the next few years, and energy and environmental law will remain at the top of the dance card. Here in Houston, we look forward to continuing our Center's work on these issues and bringing the scholarship of our faculty and students to your attention and continuing to join the national debate.

The Energy Capital of the World Reinvented: Tesla to Build Megapack Facility Near Houston: Tesla has announced plans to build a Megapack battery factory in Brookshire (Waller County), just outside Houston, with local authorities approving a tax-abatement deal to support the development. The planned facility would employ up to 1,500 people by its third year and house roughly \$150 million in manufacturing equipment along with \$44 million in site improvements. Tesla's megapacks are large-scale battery storage units designed to stabilize the grid during peak demand. This "Megafactory" would mark Tesla's first such facility in Texas and adds a significant manufacturing anchor for battery/energy storage in the Houston region. Learn more here.

Gulf Coast Hydrogen Hub Launches with \$1.2 Billion Federal Support: In late 2024, the U.S. Department of Energy and the HyVelocity consortium launched the Gulf Coast Hydrogen Hub, committing up to \$1.2 billion in federal funding to accelerate low-carbon hydrogen production along the Texas Gulf Coast. This initiative aims to slash carbon emissions by about 7 million metric tons annually, while creating tens of thousands of jobs. With new hydrogen pipelines, storage, and production facilities planned, Houston solidifies its role as a global leader in clean hydrogen innovation. Learn more here.

Houston Breaks Ground on 160 MW Grid-Scale Battery Project: In May 2025, SMT Energy, CenterPoint Energy, and Irby Construction broke ground on SMT Houston IV, a 160 MW/320 MWh battery energy storage system (BESS) within the ERCOT grid. Backed by \$135 million in financing, this project will provide critical grid stability, store renewable energy, and enhance resilience against power disruptions. The facility represents one of the largest standalone battery projects in the Houston area. Learn more here.

Offshore Wind Uncertainty as BOEM Rescinds Gulf Wind Areas: In late July 2025, the Bureau of Ocean Energy Management (BOEM) rescinded all designated Wind Energy Areas (WEAs) on the Outer Continental Shelf, including those off the Texas Gulf Coast. This sudden reversal affects over 3.5 million acres previously earmarked for offshore wind development. The move reshapes the Gulf Coast's renewable energy outlook, creating uncertainty for developers and local supply chains while sparking new legal and policy debates about the future of offshore wind in Texas

Texas Supreme Court Confirms Surface Owner Pore-Space Rights: In Myers-Woodward, LLC v. Underground Services Markham, LLC (decided May 16, 2025), the Texas Supreme Court ruled that, unless stated otherwise by contract, the surface owner—not the mineral owner—controls rights to empty subsurface pore space created during mineral extraction. This landmark decision clarifies ownership for carbon capture and storage (CCS) projects, ensuring that surface owners hold critical leverage in negotiations for underground CO₂ storage rights. 
U.S. Supreme Court Upholds NRC Licensing Authority in NRC v. Texas: On June 18, 2025, the U.S. Supreme Court issued a 6–3 decision in Nuclear Regulatory Commission v. Texas, reversing a Fifth Circuit ruling and restoring the Nuclear Regulatory Commission's license for the Interim Storage Partners (ISP) facility in Andrews County, Texas. The Court held that Texas and Fasken Land and Minerals lacked standing under the Hobbs Act because they had not been formal parties to the NRC's licensing proceeding, and thus could not judicially challenge the license. The decision does not resolve the substantive question of whether the NRC has statutory authority to license private, standalone nuclear waste storage sites, but the majority's procedural ruling bolsters federal regulatory control over nuclear waste infrastructure. Texas Advances Toward Class VI Primacy for Carbon Storage Wells: On June 9, 2025, the EPA proposed granting Texas "primacy" authority over Class VI underground injection wells used for CO₂ sequestration. Once finalized, this would allow the Railroad Commission of Texas to issue and enforce permits directly, significantly reducing regulatory delays for CCS projects. Texas would join a select group of states with primacy, positioning itself at the forefront of carbon capture deployment and climate infrastructure investment. Learn more here.

Texas Updates Oil and Gas Waste Management Regulations: After four decades, Texas updated its oil and gas waste management rules last January. The Railroad Commission adopted new regulations covering various types of waste from oil and gas operations, including drilling byproducts, geothermal, carbon sequestration, and brine mining wells. These changes modernize the design, construction, operation, monitoring, and closure requirements of waste management units, aiming to enhance oversight and environmental protection. She is committed to making significant contributions to scholarship, teaching, and upcoming events at EENR.



Rita Julien, joining from NYU School of Law, where she was a Visiting Assistant Professor of Tax Law. At NYU, she taught Taxation of Property Transactions, focusing on the federal income tax implications of investment and business transactions, and Tax Policy, examining the intersections between taxation and sustainability.

Her research has focused on international taxation, including tax treaties, tax law in the European Union, and reform efforts addressing base erosion and profit shifting. She also researches efforts to achieve the UN Sustainable Development Goals, particularly the intersection of tax law and measures to counteract illicit financial flows. As part of the Global Tax Policy Center's Tax Transparency and Corruption Project, in association with the World Bank, United Nations Office on Drugs and Crime (UNODC), and the African Tax

Institute (ATI), she has worked extensively on Unexplained Wealth Order laws, studying the role of tax authorities and the parallels with certain tax investigation techniques.

She earned her doctoral degree in business law at WU, where she was awarded the 2020 European Doctoral Tax Thesis Award, jointly presented by the EATLP and the European Commission, as well as a Wolfgang Gassner Science Prize. She obtained an LL.M. in Taxation from Georgetown Law, where she was a Graduate Tax Scholar, and an LL.M. from the University of Luxembourg's Faculty of Law, Economics, and Finance, specializing in European and International Tax Law. Previously, as a Teaching and Research Associate at WU's Institute for Austrian and International Tax Law, she taught courses and seminars on topics such as dividends and interest under tax treaties, methods for the elimination of double taxation, and Austrian tax law. She continues to teach an annual course in the LL.M. program in International Tax Law in Vienna. In 2022, she was awarded the Thomas Bradbury Chetwood, S.J. Prize in Taxation from Georgetown Law.



7th Annual Denney L. Wright International Energy Tax Conference and the 25th Annual Houston Business and Tax Law Journal Symposium, "International Energy Investment Challenges," February 28, 2025.

EENR faculty, Denney Wright and the Houston Business and Tax Law Journal hosted the 7th Annual Denney L. Wright International Energy Tax Conference. The all-day conference included panels on investment, taxes, and implications in the U.S and other countries worldwide. The conference featured a comparative discussion on clean energy tax and policy transitions affecting investments in Canada, Mexico, and the U.S. Topics also included energy investment challenges in South America and Africa, dispute resolution, updates on the U.S. Inflation Reduction Act, and the implications of international tax developments and sanctions in the energy sector. Navigating Uncertainty: The End of the Chevron Doctrine and Its Implications, September 10, 2024.

EENR faculty Professor Tracy Hester, Professor Darren Bush, and Professor Gina Warren, along with other UHLC professors, examined the Supreme Court's decision in Loper Bright Enterprises v. Raimondo at a recent C.L.E. event. The ruling effectively overturned the Chevron Doctrine, transferring the power of statutory interpretation from federal agencies to the courts. The panel discussed the resulting uncertainties in federal regulation and enforcement, highlighting significant changes in how laws will be interpreted and applied.
