Subject: OSHA Info request

I agree that Exponent should draft the responses to questions 1-14, but recommend that their work be contracted for and supervised by Collier Shannon. If we retain Exponent and supervise that project, we can maintain attorney/client privilege over all analysis they generate. Although unlikely, it is posssible that OSHA or private litigants could request such information from the Chrome Coalition or its member companies



in future personal injury lawsuits. Perhaps more important, this info request is designed to build the record for future rulemaking. Therefore, the response should include legal arguments as well as data and analysis. We need to explain to OSHA the limits on their authority to reduce the PEL (or develop a standard) from a policy and legal standpoint, as well as a health standpoint. I agree that economic and technical feasibility info must come separately, but we need to make sure that our submission reminds OSHA that they must consider both in deciding whether and how to proceed with rulemaking. I think we could do that most efficiently if we were involved at this stage in working with Exponent. I do not believe that this would be a significant undertaking on our part.
