

FREQUENTLY ASKED QUESTIONS – INTERNATIONAL APPLICANTS

(1st law degree earned outside of the United States)

1. **What LL.M. programs are offered at the Law Center?**

- Energy, Environment & Natural Resources Law
- Health Law
- Intellectual Property & Information Law
- International Law
- Tax Law
- LL.M. in U.S. Law

2. **Can I apply to any of these programs?**

Yes.

3. **Are there required courses?**

Any student who earned a law degree outside of the United States is required to take Introduction to American Law (5319) and Legal Writing(5338)* during the first fall semester of enrollment, August-December. Students in a concentration, such as International Law, are also required to complete a certain number of concentration-specific credits.

4. **When can I begin the LL.M. program?**

Lawyers who earned their law degree outside of the United States are eligible to begin their studies in early August, the Fall semester entry. Lawyers that have undertaken common law legal studies may be eligible to begin their studies in either the Spring (January) or Fall (August) semester entry.

5. **What is the length of the program?**

The LL.M. degree is a 24-credit hour program. Most students attend full time and complete the program in one academic year, August-May.

6. ***I'm working and cannot complete the program in two semesters. What are my options?***

Students have the option of taking up to three years to meet all program requirements. Students must take the two required courses in the first fall semester of enrollment. Students must, however, meet applicable visa restrictions that may require completion of the program in a shorter period of time.

7. ***When do classes begin?***

Fall Semester start—Classes begin immediately after orientation, which is typically the first full week of August.

Spring Semester start—Classes begin immediately after orientation, which is typically the first full week of January.

8. ***When are classes scheduled?***

Most classes are typically scheduled Monday-Friday throughout the day and early evening hours. The current schedule is available at <https://www.law.uh.edu/schedule/>

9. ***How do I select courses?***

Each student is assigned an advisor. Working with the advisor, students select courses to meet their professional and program requirements.

10. ***What are the admission requirements?***

Lawyers who earned their law degree outside of the United States must have earned the degree from an accredited university in the country in which the university is located or be eligible to practice before the highest jurisdiction in their country. Applicants must present evidence of a high-grade point average or superior class standing at the school where they obtained their law degree.

11. ***Am I required to take the LSAT exam?***

No.

12. ***How do I apply?***

The application and all supporting documents should be submitted through the Law School Admission Council, LSAC, at <https://www.lsac.org/>. We do not offer a direct application process.

13. ***Am I required to take the TOEFL, IELTS, or Duolingo exam?***

All graduate applicants, regardless of citizenship status must demonstrate proficiency in English to obtain admission to the university. This requirement cannot be waived. This requirement can be fulfilled in the following manner:

1. Baccalaureate degree (or higher) earned from a regionally accredited U.S. institution or at an institution at which English is the medium of instruction in the following countries: American Samoa, Anguilla, Antigua & Barbuda, Australia, Bahamas, Barbados, Belize, Bermuda, Canada (except the Province of Quebec), Cayman Islands, Dominica, Falkland Islands (Islas Malvinas), Ghana, Gibraltar, Grenada, Guam, Guyana, Ireland, Jamaica, Liberia, Micronesia Islands, Federated States of, Montserrat, New Zealand, Nigeria, Saint Kitts & Nevis, Saint Lucia, Saint Helena, South Africa, St. Vincent & the Grenadines, Trinidad & Tobago, Turks & Caicos Islands, United Kingdom (England, Scotland, Ireland, & Wales), Virgin Islands and Zimbabwe

2. TOEFL-ibt score of 79 or higher

3. IELTS-academic score of 6.5 or higher

4. Duolingo English Test -105 score or higher

The Law Center typically admits students with a TOEFL IBT score in the range of 86-100, IELTS academic score in the range of 7.0-8.5, or the Duolingo score in the range of 115-160. Additional information is available at

14. ***Do you offer conditional admission to applicants who do not meet the University's minimum TOEFL, IELTS, or Duolingo English score requirement?***

No.

15. ***Should my transcript and other academic documents be evaluated before submitted them to LSAC?***

No. Transcripts are evaluated through LSAC's International Transcript Authentication and Evaluation Service (ITAES).

16. ***How are applications evaluated?***

Academic performance, work and professional experience, the personal statement, reference letters and the English proficiency report (if applicable) are all considered in making admission decisions.

17. ***Does the application process include a personal interview?***

No. Applicants can use the Personal Statement to write about circumstances, goals, etc. that would be discussed in an interview.

18. ***Can I submit my application to LSAC before I've taken the TOEFL, IELTS or Duolingo English tests?***

Yes.

19. ***How many students are admitted each year?***

The size of an entering class varies from year to year and is not predetermined. Classes typically include recent graduates and practicing lawyers.

20. ***Is there an early admissions/decision process?***

Applications are reviewed upon receipt of all required application materials, on a rolling basis. Applicants are encouraged to submit applications, especially academic documents, to LSAC as early as possible. Candidates requiring a student visa must submit their LL.M. application no later than March 1st for the August intake or no later than December 1st for the January intake.

21. ***Once admitted, can I change from one program to another?***

No. Applications and offers of admission are program specific. Carefully review programs descriptions and requirements prior to submitting the LL.M. application. This is especially important for applicants interested in taking a bar examination that requires completion of specific courses within the student's LL.M. program.

22. ***I'm a permanent U.S. resident. Am I still considered a foreign lawyer?***

For purposes of admission to the LL.M. program, a foreign lawyer is anyone, regardless of immigration status, whose law degree was earned outside of the United States.

23. ***I'm a permanent U.S. resident. Does that qualify me as a Texas resident for tuition purposes?***

U.S. residency and Texas residency are not the same. It is possible to be a permanent U.S. resident but not a Texas resident for tuition purposes. 24. ***What are my housing options?***

Houston is a very large metropolitan city with limited public transportation. Students who will not have their own transportation are encouraged to consider campus housing such as the University Lofts, which is adjacent to the Law Center. <https://www.uh.edu/housing/housing-options/university-lofts/> Campus housing fills up very quickly and arrangements should be made upon admission to the program. 25. ***What is the cost of the program?***

Based on the 2026-2027 academic year, tuition and fees for a Texas resident are approximately \$34,397 and \$46,349 for a non-resident. (Amounts are estimates based on the current year and are subject to change.)

26. ***What expenses should I plan for in addition to tuition and fees?***

Expenses, such as housing, personal, and transportation vary depending upon individual preferences. For example, books can be purchased new or used, online or in Houston and there is a wide variety of on and off-campus housing options.

Students typically budget approximately \$2900 for books, \$26,086 for living expenses, and parking (\$55-425/per semester). Health insurance is required of all F-1 visa holders and estimated cost is \$1229-1952 per semester. It can be waived for students who already have health insurance approved by the University of Houston. Student health insurance coverage may NOT be in effect during orientation or the early weeks before the official start date of the fall or spring semester. Students need to ensure that their current insurance remains in effect until the effective coverage date of student health insurance.

27. ***Do I qualify for in-state (Texas resident) tuition?***

U.S. and Texas Residency are not the same. Go to <https://www.uh.edu/undergraduate-admissions/resources/residency-requirements/index.php> for information on qualifying as a Texas resident.

28. ***Are scholarships or other financial assistance options available to foreign LL.M. students?***

There are a limited number of Dean's Merit-Based Scholarships awarded to non-US lawyers admitted to the LL.M. program. There is no separate application required, all admitted students are considered. 29. ***After completion of the LL.M. program, am I eligible to take a bar examination?***

Each state determines eligibility requirements for their bar examination, not law schools. In October 2014, the Supreme Court of Texas published revisions to the Rules Governing Admission to the Bar of Texas. Licensed, foreign-trained lawyers may now take the Texas Bar Exam after completing a U.S. LL.M. program, such as those offered by the University of Houston Law Center. Law schools cannot confirm bar eligibility, and students planning to take a bar examination upon the completion of the LL.M. program (or for whom this may be a possibility), should research a state bar's eligibility requirements **before** beginning any program. Eligibility in some states, such as Texas, requires completion of specific courses during a student's LL.M. studies.

Students who are admitted to a specialty program, such as intellectual property, must complete more than 24 credits to meet both bar eligibility and LL.M. program requirements. Students admitted to the LL.M. in U.S. Law can meet both LL.M. program and bar eligibility requirements in 24 credits.
